### "New" GAS Pharyngitis Clinical Practice Update

The research community attests it takes 17 years for new evidence to be put into clinical practice. Implementing the once a day amoxicillin dosing for Group A streptococcal pharyngitis( GAS) using the "new" clinical practice GAS guidelines published in 2012 this year will improve the research/practice implementation gap! Once a day dosing is recommended when possible to help improve medication compliance and I have found busy parents to be happy with this treatment option. Penicillin or amoxicillin remain the treatment of choice for treatment of GAS. For patients without penicillin allergy:

- Penicillin V (oral) children: 250 mg twice daily or 3 times daily, adolescents & adults: 250mg four times daily or 500 mg twice a day for 10 days
- Amoxicillin (oral): 50 mg/kg once daily (max 1000mg) or 25mg/kg (max 500mg) twice daily for 10 days

## Health Policy/Legislative

House Bill 216 was signed by the Governor on January 4<sup>th</sup>, but changes are not yet in effect. Once signed by the governor the bill has 90 days before it becomes law. Therefore, the effective date of HB 216 will be April 4, 2017. There are many changes the nurse practitioners should be aware of, but as always, the NP should check with his/her employer as to how the changes will affect the individuals practice.

As most are aware, HB 216, also known as the APRN Modernization bill was initially introduced as a bill with no barriers. After two long years of hard work, dedication and grassroots advocacy, we succeeded. Although the bill is not a "Full Practice Authority" bill as defined by the American Association of Nurse Practitioners, there are a number of wins that will make patient care more efficient and safer. Here is a synopsis of the outcome of the bill.

### CHANGES TO THE LICENSE

1. There will now be two licenses to practice as an APRN in Ohio. The first will be an RN license and the second will be an APRN with designation as CRNA, CNM, CNS, or CNP.
2. CTP and CTP-E will be eliminated. A CNP, CNS and CNM will be awarded prescriptive authority with the APRN license.
3. There will be grandfathering of those currently in a CTP-E.
4. Beginning in 2017, APRN's must have a total of 48 hours of CE. Twenty four hours (including 1 Law CE) for RN license and 24 hours (including 12 pharm CE) for APRN license.

### CHANGES TO PRESCRIBING

5. Drug Formulary will be EXCLUSIONARY ONLY and will only list drugs that cannot be prescribed by the APRN.
6. Restrictions on furnishing samples have been eliminated.
7. Collaborating MD ratio of 3:1 has been expanded to 5:1.
8. Schedule 2 medications can now be prescribed to residents in assisted living.

### CHANGES TO THE SCA

9. Standard Care Arrangement (SCA) no longer requires a procedure for chart review or a policy for care of infants up to 12 months. Additionally, there are no longer recommendations that the collaborating MD see children from birth to 3 years.
10. Upon termination of the collaborative agreement by the physician, the NP will have 120 days to find a new collaborator.
11. A copy of SCA no longer has to be at all work sites. The SCA must be kept of file by the employer

12. A certified psychiatric clinical nurse specialist may collaborate with a psychiatric certified physician or a family medicine physician, internal medicine physician or pediatrician. THIS IS CURRENTLY FOR CNS only and DOES **NOT INCLUDE** Psych CNP. (OAPN is working on this- it was thought to be a technical issue)

## **ADVOCACY FOR OUR ROLE**

13. Ohio Board of Nursing is required to form and APRN Advisory Committee to advise the board on APRN practice issues.
14. APRN's and PA's who provide care for school age children with diabetes will be able to write orders that are followed by healthcare providers at the schools.
15. Advance Pharmacology course will be valid for five years instead of three.

As you can see there are a number of great changes. As a new general assembly ensues we will continue to pursue changes to law and rule that impact patient care.
